Student success and student safety are the two highest priorities for the Wilson Central School District. They are conjoined and both depend on the other. Wilson has been depending on an antiquated Emergency Communication system. The analog phone system is ancient and replacement parts are usually scavenged from other districts who have already decommissioned their dinosaur systems. These systems depend on cabling that has been spliced and reconnected multiple times often leading to system failure when it is needed.

Wilson is proposing the purchase and installation of a new, digital system that is operated on the existing computer network. These digital devices can communicate in a traditional manner as well as with digital messaging on the appliance. Additionally, pre-loaded messages can be delivered to groups of phones or all phones from the touch pad of the administrative phone such as "shelter in place" or secure your classroom."

Finally, these devices can be tested automatically without disrupting the students with a "ping" command from the network suppor staff.
